Linda Hellyer of Torridge DC has given £1,000 we also have £1,000 that school council have raised. Track quotes were discussed and questions asked regarding which supplier was best. Discussed whether to go for rubber matting or concrete. Questions were asked if we could use capital funding or school budget share. Also discussed could we ask the suppliers some more questions: review feedback from previous customers, how long would it take to complete the track, when could they start, clarify what materials they would use, lifetime maintenance, crossing point (what is it? 6	Update on actions	
	Running track – all quotes are in. Discussed using capital funding for the track or school budget, agreed to put it in this year's budget but to try and raise as much as we can before the track is installed. Questions were raised about the materials used on the track, when it could be installed, how long it would take to completed and when the companies could start the project. All need to be looked into and reported back to governors. March's Minutes have been signed in Governor hub. All link subject visits have been completed and Child Protection policy doesn't need updating yet, this has been looked into.	
7	Headteacher update (Verbal)	
	Verbal update given on: Attendance this is good at 96.09 %. 6 SEN children. IEP and notice and focus children have all been updated. Sept – we have a part time practitioner and admin assistant for FSU this has been recruited for and filled. Possible 2 children joining the school, waiting to hear final details. Kingsley School visited to learn about Read Write Inc and they have sent a letter saying how impressed they were about the staff teaching the RWI programme; the letter was passed to governors to read. Data increasing from year 6's 64% to 76% and across the school is 76%. 15 Pupil premium and 4 EHCP children.	
8	Finance update	
	FRS reports everyone agreed they have seen this, governors had question and these were answered. Budget was shown again and governors had questions – most were clarified but some were unanswered and needed clarifying with the Finance officer. Agreed that we would ask DCC for an extension on submitting the budget so we could answer the remaining questions about the budget then ratify it. A meeting was held on Friday 2 nd May - AD & LP via Teams and KR, LH, JC and TY in school. The budget was submitted again on GovHub for all to access and it was agreed at 3:45pm the all were in agreeance that we could publish and lock this budget. Catering costs & BT figures, questions were asked about the deficit in B&T and confirmed again that figures aren't true as playworker role has moved to FSU figures but have come out of B&T.
